
# Judges Standing for Retention General Election, November 3, 2020

There are 95 judges statewide that will appear on the 2020 general election ballot for a retention vote. This document provides information about these judges.

Iowa is divided into eight judicial districts. A chief judge, who is selected by the Iowa Supreme Court, heads each district.



Included in this information is the political party affiliation for each judge. Also included is the primary election history, since it identifies the ballot type: (D)emocrat or (R)epublican. The two major political parties have very different views on abortion, as documented in their respective state party platforms.

The Democrat party platform states under "Reproductive Rights and Family Planning" (line 932), "We support:" (line 934) "Roe vs. Wade" (line 936), and "fully funding:" (line 937) "b. PP" (line 939). Under "ACRONYMS USED IN THIS SECTION" (line 956), "PP - Planned Parenthood" (line 992). (<u>https://iowademocrats.org/wp-content/uploads/2018/09/2018-IDP-Platform.pdf</u>)

The Republican party platform states under the "Life" section, "1. We move the Iowa Republican party aggressively support a "life begins at conception" bill without exceptions.", and "2. Susan Kay Christensen Chief Justice Supreme Court	Chief Justice Christensen, Harlan, was appointed to the Iowa Supreme Court in 2018. The members of the court selected her as chief justice in February 2020. She was born and raised in Harlan, Iowa. She earned her bachelor's degree from Judson College in 1988 and her law degree from Creighton University School of Law in 1991. Prior to her appointment to the supreme court, Chief Justice Christensen was appointed a district associate judge in 2007 and a district court judge in 2015. Before becoming a judge, she practiced law in Harlan for 16 years. Chief Justice Christensen chaired the Children's Justice State Council and the Family First Task Force, and served on the Supreme Court's Family Law Pro Se Forms Committee, Child Support Guidelines Review Committee, Parents Representation Standards Committee, and Guardianship/ Conservatorship Task Force as well as the Children's Mental Health and Wellbeing Advisory Committee. She is a member of the Iowa Judges Association, the Iowa State Bar Association, the Southwest Iowa Bar Association, and the Shelby County Bar Association. Mansfield Justice	Justice Mansfield received his undergraduate degree from Harvard in 1978 and his law degree from Yale in 1982.
	After law school he clerked one year for the U.S. Court of Appeals, Fifth Circuit. Justice Mansfield then worked 26 years as an attorney in private practice until his appointment to the Iowa Court of Appeals in 2009. Two years later, Justice Mansfield joined the Iowa Supreme Court.
	Justice Mansfield has been an adjunct professor of law at Drake University since 1997, teaching subjects ranging from contracts to antitrust and sports law. Justice Mansfield is a member of the Iowa State Bar Association, having served several terms as Chair of the Trade Regulation Section. Justice Mansfield currently chairs the task force on revision of the Iowa Rules of Criminal Procedure. He is also a member of the Polk County Bar Association and the Iowa Judges Association. Justice Mansfield has previously served as a Member and a Chairperson of the Board of Directors of Goodwill of Central Iowa.
