

Introduction

There are 69 judges statewide that will appear on the 2024 general election ballot for a retention vote. This document provides information about these judges.

Iowa is divided into eight judicial districts. A chief judge, who is selected by the Iowa Supreme Court, heads each district.



Included in this information is the political party affiliation for each judge. Also included is the primary election history, since it identifies the ballot type: (D)emocratic or (R)epublican. The two major political parties have very different views on abortion, as documented in their respective state party platforms.

The 2024 Democratic Party platform states under "Reproductive Rights & Family Planning", "We support:" "Codifying Roe v. Wade" (line 761), and "Full-funding for comprehensive-family-planning-programs/providers/PP" (line 763). Under "Acronyms Used in This Section", "PP - Planned Parenthood". The 2024 Republican Party platform states under the "Life" section, "1. We believe that life begins at conception and must be protected to natural death.", and "2. We oppose using public

Iowa Supreme Court Justices



Justice May, Polk City, was appointed to the Iowa Supreme Court in July 2022. He was appointed to the Iowa Court of Appeals in April 2019 and appointed as a district judge in Judicial Election District 5C in February 2016. Justice May previously practiced law with Bradshaw, Fowler, Proctor & Fairgrave, P.C., in Des Moines. He received his undergraduate degree from the University of Missouri - Columbia, his Master of Public Health degree from the University of Oklahoma Health Sciences Center, and his law degree from Drake University Law School. **His current term expires December 31, 2024.**

David May

- Case No. 22-2036 (Fetal Heartbeat), in a 3-3 split decision, joined an opinion that would reverse the order of the district court and remand this case with directions to dissolve the permanent injunction and continue with further proceedings consistent with this opinion. The fetal heartbeat law was passed in accord with the Iowa Constitution; thus, contrary to my colleagues' assertion, it is not a "hypothetical law." It is an actual law. And contrary to my colleagues' assertion, the legislature does not need to "reenact section 146C" to demonstrate that it is an actual law. A statute once declared unconstitutional and later held to be constitutional does not require reenactment by the legislature to restore its operative force.
- Case No. 23-1145 (Fetal Heartbeat), in a 4-3 decision, joined the majority opinion holding that applying rational basis as the constitutional test, undermines the rationale for the district court's ruling. Under the rational basis test, Planned Parenthood cannot show a likelihood of success on the merits of its substantive due process challenge. We thus hold that Planned Parenthood is not entitled to a temporary injunction blocking enforcement of the fetal heartbeat statute. We reverse the order granting the temporary injunction and remand the case for the district court to dissolve the temporary injunction and continue with further proceedings.

Samuel Langholz

Judge Langholz, Ankeny, was appointed to the Iowa Court of Appeals in August 2023.

Before his appointment, he practiced law in the Executive Branch of state government for nearly thirteen years, serving as Chief Deputy Attorney General, Assistant Solicitor General, Senior Legal Counsel to the Governor, Chief Administrative Law Judge, and State Public Defender. He also previously worked in private practice at a law firm in Des Moines. He began his legal career as a judicial law clerk to Judge Steven M. Colloton on the U.S. Court of Appeals for the Eighth Circuit.

Other: Prior to his appointment to the Iowa Court of Appeals, Langholz served as an attorney for the appellant in case no. 21-0856 regarding enforcement of Amendment H-8314 to House File 594 that imposed certain requirements for women seeking an abortion, including a 24-hour waiting period. The Iowa Supreme Court held that the Iowa Constitution is not the source of a fundamental right to an abortion and reversed the district court's grant of summary judgment to Planned Parenthood.



Mary Ellen Tabor
